Onshore wind energy – pillar of the energy transition

The **future prospects** for onshore wind energy have never been better. Without a massive expansion of onshore wind energy, the energy transition cannot be achieved:

- **Decarbonisation** – The envisaged climate neutrality requires far-reaching electrification in transport, heat supply and industry. To achieve this, onshore wind energy must be massively expanded.
- **Ukraine war and energy crisis** – Russia's war of aggression against Ukraine not only violates international law but has also highlighted the very real risks of an energy shortage and resulting **high electricity prices**. Investments in new renewable energies, and onshore wind energy in particular, are therefore of paramount importance for the energy supply.
- **Favourable regulatory environment** – The EEG provides for **ambitious expansion targets** with expansion rates of 115 GW by 2035, thus creating **new incentives** for the urgently needed expansion. The European RED III also recognizes the paramount importance of wind turbines and aims to reduce bureaucratic and approval-related obstacles.
- **Lack of land and approval procedures** – Measures to **accelerate permitting procedures** by waiving environmental impact and species protection assessments and the targeted **designation of 2 % of Germany** for onshore wind energy should further reduce known hindrances to the expansion.
- **Acceptance** – Citizen participation models bring **economic benefits** and thus increase **acceptance for the expansion** of renewable energies among the (local) population.
