# U.S. software firm Fico acquires Tonbeller AG: Luther advises on acquisition

Frankfurt – The American software firm Fico, based in San Jose, California, has acquired Tonbeller AG, a company based in the German city of Bensheim. During this transaction Fico was advised by Faegre Baker Daniels in the United States.
