Luther to advise Biella Group on the acquisition of the folder supply business of Groupe Hamelin

Berlin – The Swiss Biella Group, the largest European manufacturer of folders and ring binders, has taken over the folder supply business of Groupe Hamelin effective as of 15 January 2014. It obtained legal advice from the law firm of Luther Rechtsanwaltsgesellschaft mbH. This major law firm had offered legal advice to the office supplies manufacturer already in April 2012, when the German Falken Group spun off from the Herlitz Group.

With the present acquisition, Biella Group will strengthen its strategic position as the largest European manufacturer of folders and ring binders. The purchaser is Biella Deutschland GmbH, a German subsidiary of Biella-Neher Holding AG. It took over the supply business for private label and no name folders from Groupe Hamelin, which is represented by Hamelin GmbH, Gronau (Germany). The business conducted under the brand names "Elba" and "Bantex" will, however, remain with Hamelin.
