## Luther advises Deutsche Wurlitzer GmbH on insolvency proceedings

Cologne – The machine manufacturer "Deutsche Wurlitzer GmbH" is back to business as usual. On 10 September 2013, a creditors' meeting was held at the Local Court of Bielefeld, where all creditors approved the insolvency plan of Deutsche Wurlitzer GmbH that had been presented to them. The Local Court of Bielefeld then ended the insolvency proceedings against Deutsche Wurlitzer GmbH after the company's reorganisation had been completed.

The creditors' meeting was organised on the basis of the insolvency plan filed with the Local Court of Bielefeld in mid-August 2013, which had been prepared by Dr Jürgen Bremer, who is a partner at Luther Rechtsanwaltsgesellschaft mbH.

The insolvency plan provides for, inter alia, the creditors waiving a portion of their claims; this waiver was necessary for the company's reorganisation. Upon approval of the insolvency plan, the company is now back to business as usual. The insolvency phase is over.

## **Background**

Having suffered years of losses, in February 2013, Deutsche Wurlitzer GmbH filed a petition for insolvency proceedings, applying for the right of self-administration. At the end of January 2013, the US-American Gibson Guitar Corporation, Nashville, Tennessee, sold the machine manufacturer to a team of German reorganisation experts. Thanks to this, the closure of the business could be prevented at the last minute. On 1 May 2013, the Local Court of Bielefeld instituted insolvency proceedings and confirmed

the self-administration by the company's management and by the German lawyer and auditor Hans-Peter Burghardt, Herford, as custodian during the insolvency phase.
